**Application of Commission Percentage:**

1. The Commission percentage applies only on tickets constructed using through fares from origin to destination.
2. The Commission is applicable for the ticket issued during period mentioned above based on rules and conditions.
3. The booking class of each fare component determines the commission percentage to be applied.
4. The following additional parameters must be met:
5. The O&D must be booked as a “married segment” and is issued on one ticket, subject to fare-rule and auto pricing.



6. Only the booking classes included in the table above are eligible.
7. Published fare rules and conditions apply.
8. The Commission does apply to Child and does not apply for Infant tickets.
9. The percentage commission is calculated against the base fare only, excluding all taxes, fees, and surcharges.
10. For itineraries with multiple commission percentages, the applicable commission percentage may be taken on each fare component.  
Example 1: NYC DEL L/class // BLR SFO R/class:
  - o Commission on the NYC BOM fare component is 4% for L/class.
  - o Commission on the DEL NYC fare component is 6% for R/class.
11. Non-qualifying booking classes are defined as any booking class not listed in the Commission Percentage Table above; 0% (zero) Commission applies for that sector/segment.

#### **Ticketing Instructions:**

1. All tickets must be issued on Air India (098) ticket stock.
2. Tour codes and ticket designators must be entered on ticket in the appropriate tour code and ticket designator fields.
3. Fare basis codes are to be used as per the published fare applied.
4. Bulk ticketing is not permitted. All tickets must show the applicable published fare basis code and fare value on the ticket. BT/IT in the fare box is NOT permitted.
5. Valid on AI Published Fares.
6. All Published Fare Rules will apply.
7. Published Fare incentives apply on base fare only (excludes YQ & all taxes).
8. Specified incentive levels must be **claimed** as a Front-End commission at the time of ticketing.
9. Applicable Commission to be recalled by the Agent for the refunded sectors.
10. Any debit memos associated to the commission violation plus applicable admin fee must be paid within 30 (thirty) days via ARC Memo Manager.



**Other Restrictions:**

1. All Commission percentage calculations are applicable to revenue passengers only.
2. No other discount, promotion and Commission will be applicable. Use of any other discount program in conjunction with this program will be subject to a payable debit memo.
3. Fare must auto price. Debit memos will be issued for manually priced tickets.
4. There will be ***no retroactive settlement for Commission not taken at the time of ticketing.***
5. The Agent is responsible to read and apply all published fare rules.
6. Additional compensation/commissions collected by the Agent on any ticket compensated under this offer will be recalled by Air India through an ADM along with the service fee and the Agent is responsible for refunding of overpayment upon receipt of invoice.
